

DECISION 07/2020 OF THE GOVERNING BOARD OF
THE EUROPEAN INSTITUTE OF INNOVATION AND TECHNOLOGY (EIT)

ON THE DESIGNATION OF REPORTING OFFICERS IN THE FRAMEWORK OF THE PROBATIONARY
PERIOD OF MR MARTIN KERN, DIRECTOR OF THE EIT

THE GOVERNING BOARD OF THE EUROPEAN INSTITUTE OF INNOVATION AND TECHNOLOGY,

Having regard to Regulation (EC) No 294/2008 of the European Parliament and of the Council of 11 March 2008 establishing the European Institute of Innovation and Technology¹, as amended by Regulation (EU) No 1292/2013 of the European Parliament and of the Council of 11 December 2013² (hereinafter referred to as the "EIT Regulation"), and Section 2 (i) and Section 4 (1) of the Statutes annexed to the EIT Regulation;

Having regard to Regulation (EEC, Euratom, ECSC) No 259/68 of the Council of 29 February 1968 laying down the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Communities and instituting special measures temporarily applicable to officials of the Commission³, as amended by Regulation No 1023/2013 of the European Parliament and of the Council of 22 October 2013⁴ (hereinafter referred to as the "Staff Regulations" and "CEOS"), and in particular Article 14 of the CEOS;

Having regard to the Decision concerning the appraisal for the Director of the European Institute of Innovation and Technology of 17 February 2010⁵, in particular, Section II, Articles 8, 9, 10, 11 and 12;

Having regard to the Decision 18/2019 of the Governing Board of the European Institute of Innovation and Technology (EIT) of 19 August 2019 on the appointment of the Director of the EIT;

WHEREAS

- (1) The Governing Board of the EIT by its Decision of 18/2019 appointed as EIT Director Mr Martin Kern for a period of four years.
- (2) The newly nominated Director of the EIT shall be subject to a probationary period of nine months in accordance with Article 14 of the CEOS.
- (3) The rules stipulated in the Decision on the appraisal for the Director of the EIT of 17 February 2010 are applicable by analogy.
