General description of the procedure:

Interested parties are invited to submit an expression of interest in accordance with the rules set out in this notice. Participation in this call is open on equal terms to all natural and legal persons coming within the scope of the Treaties of the European Union, and to all natural and legal persons in a third country which has a special agreement with the European Union on the conditions laid down in that agreement.

For British candidates or tenderers: Please be aware that after the UK's withdrawal from the EU, the rules of access to EU procurement procedures of economic operators established in third countries will apply to candidates or tenderers from the UK depending on the outcome of the negotiations. In case such access is not provided by legal provisions in force candidates or tenderers from the UK could be rejected from the procurement procedure. The Contracting Authority will draw up a list of vendors who have expressed their interest by submitting the documents indicated above. In a second step, only the vendors fulfilling these criteria will receive the tender specifications and will be invited to submit tenders.
