



## EX-ANTE NOTICE TRANSPORT SERVICES FOR EIT GOVERNING BOARD

1. **Tender reference:** EIT/2023/LVP/0015– Transport Services for EIT Governing Board
2. **Procedure:**  
Low value negotiated procurement procedure with minimum 3 candidates.
3. **Contracting Authority:**  
European Institute of Innovation and Technology (EIT)
4. **Type of contract:**  
Single Framework Service Contract with an estimated duration of 4 years.
5. **Contract description:**  
Provision of Ground transport services for members of the EIT’s Governing Board and other guests in Budapest or in Hungary. The transport will be carried out in executive automobiles or mini or maxi bus, as appropriate.

The following deliverables shall be provided:

- a) Ground transport from Budapest International Airport to Budapest downtown area,
- b) Ground transport from Budapest downtown area to Budapest International Airport,
- c) Ground transport around downtown Budapest,
- d) Ground transport of up to 250 km from Budapest.

6. **Indicative budget:**  
**EUR 52,000.00 for 48 months.**
8. **Eligibility criteria:**  
Participation in tendering procedures is open on equal terms to all natural and legal persons coming within the scope of the Treaties of the European Union and to all natural and legal persons in a third country which has a special agreement with the European Union on the conditions laid down in that agreement as well as to international organization.

It is also open to all natural and legal persons established in a third country which has a special agreement with the European Union in the field of public procurement on the conditions laid down in that agreement. Where the Agreement on Government Procurement concluded within the World Trade Organization applies, the participation to this call for tenders is open to all natural and legal persons established in the countries that have ratified this Agreement, on the conditions laid down therein.



After the UK's withdrawal from the EU, the rules of access to EU procurement procedures of economic operators established in third countries will apply to tenderers from the UK depending on the terms of any Withdrawal Agreement. In case such access is not provided by legal provisions in force tenderers from the UK could be rejected from the procurement procedure.

All interested economic operators satisfying the eligibility criteria indicated above are invited to submit an expression of interest indicating the tender reference number, their identity (legal entity name) and the contact person including its contact details.
