

DECISION 35/2023 OF THE GOVERNING BOARD OF THE EUROPEAN INSTITUTE OF INNOVATION AND TECHNOLOGY (EIT)

ON ADOPTING THE EIT BUDGET AMENDMENT No 2/2023

THE GOVERNING BOARD OF THE EUROPEAN INSTITUTE OF INNOVATION AND TECHNOLOGY,

Having regard to Regulation (EU) No 2021/819¹ of the European Parliament and of the Council of 20 May 2021 on the European Institute of Innovation and Technology, (hereinafter referred to as the 'EIT Regulation'), and in particular Article 21 and 22 thereof and Section 2.1 (b) of the Statutes annexed to the EIT Regulation;

Having regard to Decision 21/2019 of the Governing Board of the EIT of 25 September 2019 on the Financial Regulation of the European Institute of Innovation and Technology (hereinafter referred to as 'EIT Financial Regulation')²;

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012 (hereinafter referred to as the 'EU Financial Regulation')³;

Having regard to Commission Delegated Regulation (EU) 2019/715 of 18 December 2018 on the framework financial regulation for the bodies set up under the TFEU and Euratom Treaty and referred to in Article 70 of Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council (hereinafter referred to as the 'Framework Financial Regulation')⁴, and in particular Article 34 thereof;

Having regard to Decision 37/2022 of the Governing Board of the EIT of 14 December 2022 on adopting the EIT budget and establishment plan for the financial year 2023⁵;

Having regard to Decision 20/2023 of the Governing Board of the EIT of 21 June 2023 on adopting the EIT budget amendment No 1/2023⁶;

Having regard to Decision 39/2023 of the Director of the EIT of 26 July 2023 on the transfer of appropriations in the budget for the financial year 2034 No 1^7 ;

Having regard to Decision 41/2023 of the Director of the EIT of 15 September 2023 on the transfer of appropriations in the budget for the financial year 2023 No 2^8 ;

Having regard to Decision 43/2023 of the Director of the EIT of 20 October 2023 on the transfer of appropriations in the budget for the financial year 2023 No 39;

WHEREAS

- (1) The EIT Governing Board adopted the budget of the EIT and the establishment plan for the financial year 2023 on 14 December 2022.
- (2) The EIT Governing Board adopted the budget amendment No 1/2023 on 21 June 2023.
- (3) The EIT Director adopted Decision 39/2023 on the transfer of appropriations in the budget no 1 on 26 July 2023 in accordance with Art 26(1) of the Framework Financial Regulation.
- (4) With the budget transfer no 1, in the 'Statement of Expenditure', on Title 2 'Other building expenditure' (item 2109), the budget was reduced from EUR 97,500.00 to EUR 66,500.00, and on 'IT SW and HW expenditure' (item 2200), the budget was reduced from EUR 457,730.00 to EUR 446,130.00. Moreover, on Title 1 'Administrative Assistance' (item 1203), the expense was reduced from EUR 379,550.00 to EUR 351,150.00. This difference of EUR 71,000.00 in total, was reallocated through:
 - EUR 63,000.00 increase for building maintenance and security (Item 2101);
 - EUR 8,000.00 increase for Communication equipment, services (Item 2201).
- (5) With the budget transfer no 1, in the 'Statement of Expenditure', on Title 3 'KIC Grants' (item 3110), the payment appropriations were reduced from EUR 371,919,672.00 to EUR 371,534,672.00. This difference of EUR 385,000.00 was reallocated through:
 - EUR 250,000.00 increase on payment appropriations for strategic supervision, guidance (item 3111);
 - EUR 135,000.00 increase on payment appropriations for regional impact of KICs (Item 3115).
- (6) The EIT Director adopted Decision 41/2023 on the transfer of appropriations no 2 on 15 September 2023 in accordance with Art. 26(1) of the Financial Framework Regulation.
- (7) With the budget transfer no 2, in the 'Statement of expenditure', on Title 1 'Staff expenditure', the budget of remuneration and allowances of temporary staff (Item 1100) was decreased from

EUR 5,150,000.00 to EUR 4,796,000.00. This difference of EUR 354,000.00 was reallocated through:

- EUR 100,000.00 increase for remuneration and allowances of contract staff (item 1110);
- EUR 86,000.00 increase for schooling (Item 1120);
- EUR 88,000.00 increase for kindergarten (Item 1121);
- EUR 10,000.00 increase for recruitment (Item 1122);
- EUR 70,000.00 increase for Agency staff (item 1200).
- (8) With the budget transfer no 2, in the 'Statement of Expenditure', on Title 2 'Other building expenditure' (Item 2109), the budget was reduced from EUR 66,500.00 to EUR 56,500.00, and on 'Furniture' (Item 2110), the budget was reduced from EUR 65,500.00 to EUR 33,500.00. This difference of EUR 42,000.00 in total, was reallocated through:
 - EUR 12,000.00 increase for building, office rental (Item 2100);
 - EUR 29,000.00 increase for building maintenance (Item 2101);
 - EUR 1,000.00 increase for transports costs (item 2302).
- (9) With the budget transfer no 2, in the 'Statement of Expenditure', on Title 3, the commitment appropriations for brand management related expenses (Item 3202) were decreased from EUR 1,380,000.00 to 1,347,150.00. The difference of EUR 32,850.00 was reallocated through an increase of EUR 32,850.00 for the EIT Awards (Item 3204).
- (9) The EIT Director adopted Decision 43/2023 on the transfer of appropriations no 3 on 20 October 2023 in accordance with Art. 26(1) of the Financial Framework Regulation.
- (10) With the budget transfer no 3, in the 'Statement of expenditure', the overestimated budget on Title 1 'Staff expenditure' was decreased on the following items:
 - Remuneration and allowances TAs (Item 1100), from EUR 4,796,000.00 to EUR 4,404,800.00;
 - Expenses and allowances TAs (Item 1101), from EUR 100,000.00 to EUR 79,400.00;
 - Remuneration and allowances CAs (Item 1110), from EUR 1,350,000.00 to EUR 1,323,700.00;
 - Recruitment (Item 1122), from EUR 35,000.00 to EUR 30,000.00;
 - Medical expense (Item 1124), from EUR 24,000.00 to EUR 10,000.00;
 - Training (Item 1125), from EUR 25,000.00 to EUR 18,000.00;
 - Trainee (Item 1202), from EUR 186,000.00 to EUR 141,000.00.

The difference of EUR 509,100.00 in total was reallocated within Title 1, as follows:

- EUR 10,000.00 increase for missions (Item 1123);
- EUR 230,000.00 increase for agency staff (Item 1200);
- EUR 7,000.00 increase for Seconded National Experts (Item 1201);
- EUR 262,100.00 increase for administrative assistance (Item 1203).
- (11) With the budget transfer no 3, in the 'Statement of Expenditure', on Title 2 'Building, equipment and miscellaneous expenditure', was decreased on the following items:
 - Building maintenance (Item 2101), from EUR 295,300.00 to EUR 290,400.00;
 - Other building expenditure (Item 2109), from EUR 56,500.00 to EUR 38,500.00;
 - Furniture (Item 2110), from EUR 33,500.00 to EUR 18,900.00;



- Communication (Item 2201), from EUR 78,000.00 to EUR 72,000.00;
- Postage and delivery (Item 2301), from EUR 4,500.00 to EUR 1,500.00;
- Legal expense (Item 2303), from EUR 70,000.00 to EUR 3,500.00;
- Handling and moving (Item 2304), from EUR 3,000.00 to EUR 0.00;
- Subscriptions, Publications (Item 2305), from EUR 2,000.00 to EUR 0.00.

This difference of EUR 118,000.00 in total, was reallocated within Title 2, as follows:

- EUR 77,000.00 increase for IT software and hardware (Item 2200);
- EUR 1,000.00 increase for Transport costs (Item 2302);
- EUR 3,000.00 increase for Meeting expense (Item 2308);
- EUR 37,000.00 increase for other administrative expense (Item 2309).
- (12) With the budget transfer no 3, In the 'Statement of expenditure', on Title 3 'Operational expenditure', the budget was decreased on the following items:
 - Strategic supervision and monitoring (Item 3111), from EUR 926,984.00 to EUR 916,984.00;
 - EIT Alumni (Item 3203), from EUR 100,700.00 to EUR 48,700.00;
 - International cooperation (Item 3205), from EUR 9,000.00 to EUR 0.00.

This difference of EUR 71,000.00 in total was reallocated within Title 3, as follows:

- EUR 10,000.00 increase for EIT Label (Item 3112);
- EUR 61,000.00 increase for monitoring and evaluation (Item 3206).
- (13) In addition, in the 'Statement of revenue', on Title 2 'Contributions', the EIT recovered from the Guarantee Fund an amount of EUR 2,369,446.81 from EIT Manufacturing, EIT Food and EIT Raw Materials.
- (14) In order to purchase new IT software, an additional EUR 1,256.00 shall be transferred as follows:
 - Building and maintenance (Item 2101), the budget is to be decreased from EUR 290,400.00 to EUR 289,144.00, and the difference is to be transferred to IT software and hardware (Item 2200)
- (15) Furthermore, to proceed with the December salary increase and the positive increase correction of the country coefficient, the budget shall be decreased on the following items:
 - Recruitment (Item 1122), from EUR 30,000.00 to EUR 24,000.00;
 - Administrative Assistance (Item 1203), from EUR 613,250.00 to EUR 460,250.00;
 - Furniture (Item 2110), from EUR 18,900.00 to EUR 0.00;
 - Expenditure related to EIT Governing Board (Item 2306), from EUR 428,000.00 EUR to EUR 343,000.00;
 - Strategic supervision (Item 3111), from EUR 863,300.00 to EUR 821,355.00 on commitment appropriations; on commitment appropriations;
 - EIT Label (Item 3112) from EUR 121,500.00 to EUR 100,295.00 on commitment appropriations;
 - Regional Impact (Item 3115), from EUR 138,250.00 to EUR 125,500.00 on commitment appropriations and from EUR 441,685.00 to EUR 365,785.00 on payment appropriations;



- EIT Alumni (Item 3203), from EUR 90,700.00 to EUR 33,500.00 on commitment appropriations and from EUR 100,700.00 to EUR 43,500.00 on payment appropriations.

The difference of EUR 396,000.00 in total shall be reallocated within Title 1, as follows:

- EUR 293,000.00 increase for Remuneration and allowances Tas (Item 1100);
- EUR 7,000.00 increase for Expenses and allowances TAs (Item 1101);
- EUR 96,000.00 increase for Remuneration and allowances CAs (Item 1110).
- (16) As part of the implementation of actions under the Single Market Programme, the Commission's DG GROW indicated that it will allocate an amount of EUR 4,000,000.00 to the action "European Solar Academy", to be implemented via indirect management by the EIT via a Contribution Agreement. This will impact the EIT budget 2023 as follows:
 - The 'Statement of Revenue', Chapter 20 Contributions, article item 204 "Other contribution external revenue" shall be increased by EUR 4,000,000.00 for both commitment and payment appropriations.
 - The 'Statement of Expenditure', Title 3 'Operational Expenditure', item 3116 Other grants, shall be increased by EUR 4,000,000 for both commitment and payment appropriations.
- (17) Following receipt of the EFTA contributions by EIT, due to round up, EUR 1.00 shall be added to the payment appropriations the 'Statement of Revenue', Chapter 20 Contributions and in Title 3 Operational Expenditure, increasing accordingly the EIT's payment appropriation on item 3110 Grants and Knowledge Innovation Communities.
- (18) Following the adoption of the present budget amendment, the EIT shall not request the initially planned payment appropriations under RO contributions (Item 203) for an amount of EUR 24,600,000.00.

HAS DECIDED AS FOLLOWS:

Article 1

The budget amendment No 2/2023, with the breakdown detailed in the Annex I to this decision, is hereby adopted for a total commitment appropriation of **EUR 434,316,643.02** and for a total payment appropriation of **EUR 367,611,612.02**.

Article 2

This decision shall enter into force on the date of its signature.
