OF THE GOVERNING BOARD OF

THE EUROPEAN INSTITUTE OF INNOVATION AND TECHNOLOGY (EIT)

ON ENDORSING THE START-UP PHASE OF EIT CULTURE & CREATIVITY AND FINALISATION OF THE NEW KIC'S DESIGNATION PROCESS

THE GOVERNING BOARD OF THE EUROPEAN INSTITUTE OF INNOVATION AND TECHNOLOGY,

HAVING REGARD to Regulation (EU) No 2021/819 of the European Parliament and of the Council of 20 May 2021 on the European Institute of Innovation and Technology (recast) (hereafter referred to as the "EIT Regulation (recast)")¹, in particular Articles 6(c), 9, and 11(1) thereof, point 1(e)-(f) of Section 2 of the Statutes as annexed to the EIT Regulation (recast);

HAVING REGARD to Regulation (EU) 2021/695 of the European Parliament and of the Council of 28 April 2021 establishing Horizon Europe – the Framework Programme for Research and Innovation, laying down its rules for participation and dissemination, and repealing Regulations (EU) No 1290/2013 and (EU) No 1291/2013 (hereafter referred to as the "Horizon Europe Regulation")²;

HAVING REGARD to Decision 2021/820 of the European Parliament and of the Council of 20 May 2021 on the Strategic Innovation Agenda of the European Institute of Innovation and Technology (EIT) 2021-2027: Boosting the Innovation Talent and Capacity of Europe and repealing Decision No 1312/2013/EU (hereafter referred to as the "EIT SIA 2021-2027")³, in particular Section 3.3 thereof;

HAVING REGARD to Regulation (EU, Euratom) No 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 101/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012 (hereafter the EU Financial Regulation)⁴;

HAVING REGARD to Decision 21/2019 of the Governing Board of the EIT of 25 September 2019 on adopting the Financial Regulation for the European Institute of Innovation and Technology, in particular Article 1 thereof⁵;

HAVING REGARD to Decision 18/2021 of the Governing Board of the EIT of 7 May 2021 on the rules of procedure of the EIT Governing Board and Executive Committee⁶;

HAVING REGARD to Decision 38/2021 of the Governing Board of the EIT of 8 October 2021 on the approval of the Call for Proposals 2021 for a new EIT Knowledge and Innovation Community (KIC) in the Cultural and Creative

Sectors and Industries (CCSI)⁷, as amended by Decision 44/2021 of the Governing Board of the EIT of 25 November 2021⁸;

HAVING REGARD to Decision 17/2022 of the Governing Board of the EIT of 8 June 2022 on the approval of the results of the panel of experts' evaluation stage in the Call for Proposals 2021 for a new EIT Knowledge and Innovation (KIC) in the Cultural and Creative Sectors and Industries (CCSI)⁹;

HAVING REGARD to Decision 18/2022 of the Governing Board of the EIT of 22 June 2022 on the selection and designation of the EIT Knowledge and Innovation Community (KIC) in the area of Cultural and Creative Sectors and Industries¹⁰, in particular Articles 2 and 5 thereof;

HAVING REGARD to Decision 19/2022 of the Governing Board of the EIT of 22 June 2022 on the allocation of the financial contribution for the Start-up grant to the newly designated Knowledge and Innovation Community (KIC) 'EIT Culture & Creativity'¹¹;

HAVING REGARD to Decision 05/2023 of the Governing Board of the EIT of 14 March 2023 on the principles for the determination of the initial EIT financial allocation for 2024-2025 to the Business Plan 2024-2025 of the Knowledge and Innovation Community EIT Culture & Creativity (EIT CC)¹²;

HAVING REGARD to Decision 40/2023 of the Governing Board of the EIT of 23 November 2023 on the progress of EIT Culture & Creativity in achieving the milestones of the start-up phase¹³;

HAVING REGARD to Decision 42/2023 of the Governing Board of the EIT of 15 December 2023 on the on the adoption of the Final Single Programming Document (2024-2026) of the EIT¹⁴;

HAVING REGARD to the Invitation to submit a proposal for the KIC Business Plan of Culture & Creativity 2024-2025 (hereafter referred to as 'Invitation 2024-2025')¹⁵;

WHEREAS

- (1) On 22 June 2022, the EIT Governing Board designated a new KIC in the 'Cultural and Creative Sectors and Industries' thematic area, EIT Culture & Creativity. Article 5 of the Designation decision states that "upon the condition that the KIC has demonstrated the successful achievement of the main milestones of the start-up phase, by late 2023 the EIT Governing Board will decide on the endorsement of the start-up phase and on authorising the EIT Director to sign the Partnership Agreement with the KIC".
- (2) On 22 June 2022, the EIT Governing Board decided that the maximum EIT financial contribution for the start-up grant for EIT Culture & Creativity shall be EUR 6 million, covering the period from the date of submission of the Start-up Plan until 31 December 2023.

- (3) On 17 February 2023, the EIT decided to award a maximum amount of EUR 5,995,362.13 for the implementation of the Start-up Plan of EIT Culture & Creativity¹⁶. On 24 February 2023, the Start-up Grant Agreement 2022-2023 was signed by the parties.
- (4) On 24 April 2023, the 'Invitation to submit a proposal for the KIC Business Plan of EIT Culture & Creativity 2024-2025' was launched by the EIT, with a deadline to submit the KIC's first Business Plan on 28 September 2023. The KIC submitted its Business Plan 2024-2025, which was evaluated by independent external experts.
- (5) On 29 October 2023, Amendment no. 1 of the Start-up Grant Agreement 2022-2023 was signed by both parties and it entered into force. This amendment ensured the accession of the newly created KIC Legal Entity, and the update of the Start-up Plan and budget, while the total budget for the start-up phase was not affected by the amendment.
- (6) By its Decision 40/2023 of 23 November 2023, as a result of the assessment of the start-up phase milestones and deliverables available so far, and within the framework of several parallel processes, such as
 - a) the EIT GB Rapporteur visit on 6 September 2023,
 - b) the assessment of the Interim Progress Report which described the progress made by the start-up consortium under the SUGA until 31 August 2023,
 - c) the assessment of the KIC's draft Strategic Agenda 2024-2027
 - d) the assessment of the KICs Business Plan 2024-2025 proposal, and
 - e) the hearing with the EIT Governing Board on 21 November 2023,

the Governing Board defined conditions in the areas of governance, partnership, the KIC Strategic Agenda and Business Plan 2024-2025.

- (7) Decision 40/2023 stated that the progress in the completion of the start-up phase will be reviewed during the EIT Governing Board meeting in March 2024. In case of its positive assessment, the EIT Governing Board will endorse the start-up phase of the KIC, will finalise the designation process and will authorise the EIT Director to sign the Partnership Agreement with the KIC. In case of its negative assessment, the EIT Governing Board will conclude that the KIC has failed to achieve its legal readiness and/or operational capacity within due time in the start-up period.
- (8) Following the adoption of Decision 40/2023, in December 2023 the KIC set-up an action plan in order to address the conditions of the EIT Governing Board. The progress of meeting the conditions has been reported to the EIT on a weekly/bi-weekly basis from December 2023.
- (9) Upon the expiry of the Start-up Grant Agreement 2022-2023:
 - a. by 31 December 2023 the KIC submitted the outstanding start-up phase deliverables;
 - b. by end of February 2024, the KIC submitted its Final Report under the Start-up Grant Agreement 2022-2023, also providing further substantial information regarding the state-of-play in achieving the milestones and deliverables of the start-up phase.
- (10) As a result of the above, the EIT acknowledges the progress shown in the areas of the conditions set by the EIT Governing Board, in particular regarding governance. Additionally, the KIC submitted a revised version of the draft Strategic Agenda 2024-2027 and of the KIC Business Plan 2024-2025 proposal, and has also demonstrated progress in the area of partnership review.

(11) Therefore, the EIT Governing Board concludes that EIT Culture & Creativity KIC has achieved the main milestones of the start-up phase, and decides to endorse the start-up phase and to finalise the designation process of the KIC.

HAS DECIDED AS FOLLOWS:

Article 1

Endorsement of the start-up phase in order to finalise the new KIC's designation process and authorisation of the EIT Director to sign the Partnership Agreement with EIT Culture & Creativity

- (1) The start-up phase of EIT Culture & Creativity is endorsed and the finalisation of the KIC designation process is approved by the EIT Governing Board.
- (2) The EIT Director is authorised to sign the Partnership Agreement with EIT Culture & Creativity for 7 years covering the period from 1 January 2024 until 31 December 2030, following his approval of the latest version of the KIC Strategic Agenda 2024-2027.

Article 2 Entry into force

This decision shall enter into force on the day of its signature.
