SUMMARY RECORDS FROM 2nd Annual Meeting of the EIT Member State Representatives Group (MSRG)

30 May 2024, 10h – 13h00 CET, online via MS Teams

The agenda of the meeting (Annex 1) and the list of participating countries (Annex 2) is enclosed.

The meeting was co-chaired by Martin Kern, EIT Director and Co-Chairperson of the MSRG and Peter Spyns, MSRG Representative of Belgium and Co-Chairperson of the MSRG.

Representatives from the European Commission (DG EAC) and the EIT also attended the meeting.

- MSRG Opinion on the extension/termination of the Partnership Agreement where the MSRG agreed that the EIT will launch a 2-step written procedure to conclude the adoption of the MSRG Opinion on the extension of the Partnership Agreement with EIT Food reflecting the comments raised during the meeting;
- European Commission update on main priorities and developments;
- EIT update on the strategic priorities and implementation of the EIT Strategic Innovation Agenda (SIA) 2021-2027 and the New European Innovation Agenda (NEIA) including the EIC-EIE-EIT relations and the synergies with EU Partnerships and Missions, the participation of higher education institutions in the EIT educational activities, the EIT Regional Innovation Scheme, the EIT Deep Tech Talent Initiative, the EIT Go Girls Circular programme as well as an update on EIT data on eCORDA and the timeline for EIT Water;
- Outlook to the EIT strategic input to FP10 and presentation of the key topics discussed at the meeting with the Research Working Party on 23 April 2024;
