3	Purposes of the processing	<p>The purpose of the processing of personal data is to manage the following procedures and processes:</p> <ul style="list-style-type: none"> <li>- <b>launch the EIT Call for Proposals 2025 for a new EIT Knowledge and Innovation Community (KIC) in the Water, Marine and Maritime Sectors and Ecosystems</b> with the use of eGrants,</li> <li>- <b>to evaluate the proposals</b> with the involvement of an EIT Evaluation Committee, independent external experts and the EIT Governing Board,</li> <li>- <b>to designate the consortium which submitted the winning proposal</b> (i.e. the designation decision is taken by the EIT Governing Board),</li> <li>- <b>to notify the applicant consortia of the result</b> and ensure them the remedy procedures, as required by the applicable rules.</li> </ul>

		<p><b>Third parties subject to the GDPR<sup>4</sup> and third parties not subject to the GDPR:</b></p> <ul style="list-style-type: none"> <li>- <i>Independent external experts and Independent Observer</i> are selected, contracted and assigned by the EIT to evaluate the proposals in line with the evaluation criteria indicated in the call text and observe the process of the call. Therefore, the experts receive the proposal documents for evaluation purposes.</li> <li>- Exceptionally and if necessary, information concerning the call procedure may be transferred to <i>external lawyers (advocates), IT contractors</i> subject to the GDPR for specific and limited purposes only.</li> <li>- The EIT does not transfer any personal data to entities established in third countries not subject to GDPR. Nevertheless, very exceptionally, external experts/external lawyers/IT contractors may come from third countries, not subject to the GDPR.</li> </ul> <p>In all these cases a written contract (an expert contract or a service contract) is signed between the EIT and the external expert/external lawyers/IT contractor in order to ensure that Article 29 of the Regulation is respected by the data processor. These written contracts follow the model of the Commission and include a specific article on data protection.</p>
