



SUMMARY RECORDS FROM 3rd Annual Meeting of the EIT Member State Representatives Group (MSRG)

5 November 2024, 9h00 – 16h30 CET, EIT House, Brussels

The meeting was co-chaired by Martin Kern, EIT Director and Co-Chairperson of the MSRG and Peter Spyns, MSRG Representative of Belgium and Co-Chairperson of the MSRG. Ilaria Tagliavini, Head of Operations Innovation, Education and Communication deputised for Martin Kern during the morning session and co-chaired the meeting.

Representatives from the European Commission (DG EAC), the EIT KICs and the EIT also attended the meeting.

 collaboration with Member States and associated countries in these areas under the current Horizon
 Europe framework and reflect on adjustments for the future outlook;
- EIT update on the implementation of the EIT 2024 Work Programme including the timeline and the Call evaluation criteria for EIT Water, the EIT Regional Innovation Scheme, the EIT Higher Education Initiative and the EIT Deep Tech Talent Initiative as well as the EIT Future Vision to FP10;
