

## CALL FOR APPLICATIONS

### Policy Assistant (Contract Agent FG III) EIT (Budapest)

Ref.: EIT/CA/2013/82

The European Institute of Innovation and Technology (EIT), established on 11 March 2008 by the European Parliament and the Council, aims to become a flagship for excellence in European innovation. The EIT is the first European initiative to integrate fully the three sides of the 'Knowledge Triangle' (higher education, research, business-innovation) and will seek to stand out as a world-class innovation-oriented reference model, inspiring and driving change in existing education and research institutions. Conceived with a clear market-driven focus, the EIT will favour sustainable economic growth and job creation throughout the Union by generating new skills, products, services and business responding both to public demand and to the needs of the knowledge economy.

The EIT is now organising a call for expressions of interest with a view to establishing a reserve list for Contract Agents for the profile of **Policy Assistant**. The place of employment will be Budapest, where the EIT seat is located.

### The job

#### 1 Profile

Reporting to the Head of Unit "Policy and Communications", the Policy Assistant will be part of the "Policy Support and Stakeholder Relations" team. (S)he will contribute to activities in strategic and policy processes led by the EIT as well as stakeholder relations.

In particular, the "Policy Support and Stakeholder Relations" team provides policy and strategic advice to the EIT Director in developing and implementing the EIT's strategy and stakeholder engagement. It supports analysis of potential synergies of and complementarities with other EU/ national/ regional innovation support mechanisms offering scope for alignment at EIT and/or KIC level. It facilitates and follows up to the preparation and implementation of the EIT's Strategic Innovation Agenda (SIA) and the rolling Triennial Work Programme (TWP). The team liaises with the EIT Foundation (EITF) and maintains links with the EITF Working Groups. It is responsible for further developing and implementing a strategy for enhanced stakeholder engagement through targeted and stakeholder-specific collaboration schemes (including the proposed future "EIT Stakeholder Forum"). Moreover, it provides the interface for relations with Third Countries and international organizations.

#### 1.1 Tasks

- Conducting desktop research on policy and stakeholder related issues;
- Supporting the monitoring of the relevant political landscape/ policy framework and stakeholder positioning;
- Contributing to providing strategic advice and support in policy issues and related processes;
- Supporting the establishment and maintenance of relations with EIT stakeholders, notably universities, research organisations and businesses, as well as EU Institutions and Member States;
- Assisting in the development and implementation of tools to engage with stakeholders;

- Assisting in the co-ordination of strategic documents (e.g. the Strategic Innovation Agenda and the rolling Triennial Work Programme (TWP)) of the EIT;
- Assisting in stakeholder consultations wherever relevant;
- Support the monitoring of KIC activities in the framework of the annual grant cycle, including the implementation of KIC business plans and activities, report on progress as needed and advise on strategy issues;
- Provide analysis and review of documents including KIC activity implementation reports to ensure their quality and consistency with KIC business plans;
- Support in demonstrating the value for money for policy analysis, including supporting the EIT on the follow-up of key performance indicators.

## **Qualifications and experience required**

### **2 Eligibility criteria**

#### **2.1 General conditions**

By the closing date of this call candidates must:

- be nationals of a Member State of the European Union or an EFTA State<sup>1</sup>;
- enjoy their full rights as citizens<sup>2</sup>;
- have fulfilled any obligations imposed by national laws concerning military service;
- meet the character requirements for the duties involved;
- be physically fit to perform their duties<sup>3</sup>

#### **2.2 Education**

Candidates are required to have

- post-secondary education attested by a diploma, **or**
- secondary education attested by a diploma giving access to post-secondary education and appropriate professional experience of three years<sup>4</sup>.

Only qualifications issued by EU Member State authorities and qualifications recognised as equivalent by the relevant EU Member State authorities will be accepted<sup>5</sup>.

#### **2.3 Experience**

Candidates must have, at the closing date for applications, at least 4 years<sup>4</sup> (at least 7 years in the case of secondary education) professional experience, including professional experience directly relevant to the tasks of at least 2 years.

##### **2.3.1 Language skills**

Candidates must have a thorough knowledge of one of the languages of the EU and a satisfactory knowledge of another language of the EU<sup>6</sup> to the extent necessary for the performance of his/her duties.

<sup>2</sup> Prior to the appointment, the successful candidate will be asked to provide a Police certificate confirming the absence of any criminal record.

<sup>3</sup> Before being engaged, a member of staff shall be medically examined by one of the institution's medical officers.

<sup>4</sup> Professional experience will be counted from the date on which the applicant acquired the minimum qualification for access to the profile in question. Only duly documented professional activity (i.e. remunerated employment or self-employment) is taken into account. Part-time work will be taken into account in proportion to the percentage of full-time hours worked. Periods of education or training and unremunerated traineeships are not taken into account. Fellowships, grants and PhDs can be counted as professional experience up to a maximum of 3 years. Any given time period can be counted only once (e.g. if the applicant had a full-time job and did freelance consultancy work in the evenings and weekends, the days spent on the latter will not be added to the period of the former).

<sup>5</sup> In case of qualifications issued by authorities outside EU Member States, the proof of recognition of equivalence by the relevant EU Member State authorities must be specifically mentioned in the online application form under "Additional information". In case of invitation to an interview, the above proof must be provided.

### 3 Selection criteria

Essential:

- Suitability to perform the tasks described in Section 1.1;
- Thorough knowledge of EU decision-making processes, its institutions and policies;
- Good understanding of stakeholder engagement processes;
- Excellent administrative and analytical skills;
- Excellent command of both oral and written English;
- Ability to communicate in a logical and structured manner;
- Ability to work well with others as well as independently;
- A pro-active and dynamic working attitude;
- Analytical skills and ability to synthesize and integrate ideas and concepts, including proven experience on working with impact measures on policy and with tools such as key performance indicators.

Advantageous:

- Proven experience and capacity to analyse the impact of Knowledge Triangle activities;
- Experience of working in a multicultural environment, preferably with a multidisciplinary approach;
- Experience in working with stakeholders from the Knowledge Triangle (namely academia, research, and innovation/ business);
- Experience gained in an EU Institution/ Agency in the field of procurement;
- Ability to work well under pressure and to respond quickly to new demands;

## The Selection process

### 4 How to apply

Please consult the Guide for Applicants on the [EIT website](#). It contains detailed instructions to help you submit your application correctly.

Only applications online through the EU CV Online system<sup>7</sup> will be accepted.

To apply, you must register in the EU CV Online system via the link provided on the EIT website, and follow all instructions concerning the various stages of the procedure. Applications shall be made in English. **Before applying, you should carefully check whether you meet all the eligibility criteria.**

It is your responsibility to complete your online registration in time. We strongly advise you not to wait until the last few days before applying, since heavy Internet traffic or a problem with the Internet connection could lead to your online registration being interrupted before you complete it, thereby obliging you to repeat the whole process. Once the deadline has passed, you will no longer be able to register.

No supporting documents are required at this stage – these will be required later from candidates invited to interview (see section 5.3).

On completion of your online registration, you will receive on screen a registration number, which you must note. Once you receive this number, the registration process is finished. This will be your reference number in all matters concerning your application. If you do not receive a number, your application has not been registered!

## **5 Steps of the selection procedure**

### **5.1 Admission to the selection procedure**

After the deadline for online registration, the selection committee will check the submitted applications against the general and specific conditions described in Section 2. Applications satisfying these conditions will then be assessed against the selection criteria under Section 3.

### **5.2 Initial assessment of the applications**

The selection committee will assess each eligible application according to the qualifications and training, professional experience and motivation of the candidate with respect to the profile described in Section 1.1.

### **5.3 Written tests and interview**

Upon completion of the profiles' evaluation, the 8 most suitable candidates for the post will be invited to undergo written tests and an interview, which will be held in Budapest (Hungary).

*Details of the time, date and address of the tests and interview will be communicated to candidates in due time.*

Candidates invited to this stage of the selection procedure will be requested to submit electronically, prior to the tests/interview, a non-certified copy of their diploma(s) and evidence of their professional experience, clearly indicating the starting and finishing dates, the function(s) and the exact nature of the duties carried out.

Prior to contract signature, the successful candidate(s) will be required to provide original versions of documents proving the eligibility criteria.

The written test(s) shall consist of the following components, in accordance with the level and profile of the position advertised:

- General aptitudes and language abilities to the extent necessary for the performance of their duties,
- Knowledge of EU integration and institutions and the EIT
- Specific competencies with reference to the profile.

The above-mentioned components can be combined.

An interview with the selection committee will take place on the same day as the written test(s). The selection committee will then carry out an assessment of the candidates according to the selection criteria described in Section 3.

The interview and written tests will be done in English.

### **5.4 Verification of documents and scrutiny**

The candidates' application will be checked against supporting documents provided in order to confirm the accuracy and eligibility of the application.

If, at any stage in the procedure, it is established that the information in an application has been knowingly falsified, the candidate will be disqualified from the selection process.

You will also be disqualified if you:

- do not meet all the eligibility criteria;
- do not provide all the required supporting documents.

## 5.5 Reserve list

The selection committee will place the most suitable eligible candidates on a draft reserve list, which will be drawn up in order of merit. This draft will be submitted to the Appointing Authority of the EIT for approval. The adopted reserve list will be valid until 31 December 2014. Reserve lists may be extended by decision of the EIT. Prior to being offered a post, candidates on a reserve list may be required to undergo further evaluation by the EIT (e.g. including a further interview).

Inclusion on a reserve list does not imply any entitlement to employment in the EIT.

## 5.6 Information

The text of this Call for applications contains all the information required. Nevertheless, if you have a question, please consult the Guide for applicants on the EIT website. ## Other important information

### 6 General information

#### 6.1 Equal opportunities

The EIT applies a policy of equal opportunities and accepts applications without discrimination on any grounds.

#### 6.2 Selection committee

A selection committee will be appointed. Please note that the Selection Committee's internal proceedings are strictly confidential and that any contact with its members is strictly forbidden.

#### 6.3 Approximate timetable

The selection process may take some months to be completed; no information will be released during this period.

#### 6.4 Recruitment conditions / Career

Successful candidates may be offered a contract as a contract agent in accordance with Article 3a of the [Conditions of employment of other servants of the European Communities](#) for an initial period of 5 years. The place of employment will be Budapest (Hungary).

The contract may be renewed for a further period of up to 5 years.

#### 6.5 Conditions of employment

Successful applicants who are offered a contract of employment will be placed on entry into service in grade 8, 9 or 10 in function group III, according to the length of their professional experience. The estimated net monthly salaries for Contract Agents at the grades mentioned above, as at 1 January 2013 in Budapest<sup>8</sup>, are:

- Grade 8: € 1 675,33
- Grade 9: € 1 894,76
- Grade 10: € 2 102,10

Depending on the individual family situation and the place of origin, staff members may be in addition entitled to:

<sup>8</sup> This estimate already includes a correction coefficient of 79.2%, currently applied to salary and allowances paid in Budapest. Deductions for the community tax and contributions for medical insurance, pension and unemployment insurance are already included in this estimate. Salaries are exempted from national tax. The salary will be paid in the local currency: Hungarian Forint (HUF).

- Expatriation or foreign residence allowance (16 % or 4 % of the basic salary)
- Household allowance (2% of basic salary + €170.52)
- Dependent child allowance (€372.61 / child)
- Education allowance (The EIT shall cover schooling fees for children of EIT staff members attending or applying to international schools that have signed a cooperation agreement with the EIT. Covered under these provisions are staff member`s children from the age of 5, and attending, regularly or on full time basis, or applying for primary or secondary education in an international school, after having been considered eligible by the EIT)
- Installation allowance (one or two basic salaries if the period of service is three years or more)
- Reimbursement of removal costs
- Initial temporary daily subsistence allowance (Staff entitled to the household allowance: €39.17 per day for a period of 180 days; if you are a probationer, the daily subsistence allowance is granted for the period of probation plus one month; Staff not entitled to the household allowance: €31.58 per day for a period of 120 days)

Other features of working conditions applicable at the EIT are:

- Annual leave entitlement of two days per calendar month plus additional days depending on distance from the place of origin, grade, age
- General and applicable technical training plus professional development opportunities
- EU Joint Sickness and Insurance Scheme, accident and occupational disease insurance coverage, unemployment and invalidity allowance
- After 10 years of service, staff members are eligible to receive pension from the European Union Pension Scheme

#### **6.6 Independence and declarations of interest**

The job holder will be required to enter into a commitment to act independently in the public interest and to make complete declarations of any direct or indirect interests that might be considered prejudicial to his or her independence.

#### **6.7 Appeal procedure**

Candidates considering that their interests have been prejudiced in the selection process by a particular decision may request a review of, or launch an appeal against the decision adversely affecting them. Further information about the appeal procedures can be found in the Guide for Applicants on the EIT website.

#### **6.8 Protection of personal data**

As the body responsible for organising the competition, the EIT ensures that applicants' personal data are processed as required by Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data (Official Journal of the European Communities, L 8 of 12 January 2001). This applies in particular to the confidentiality and security of such data.
